

In all Foundation endeavors over the course of 2022, the most critical element of our success has been the remarkable, uncompromising support of each of you. Texas A&M University-Kingsville and the Texas A&M University-Kingsville Foundation continue on a path to sustained greatness primarily because of your generosity.

The Foundation never wavered its continued support and saw a total of \$4,126, 226 distributed to our university leadership, faculty and students.

More than \$575,000 was raised by our loyal and dedicated university supporters during the 2022 Javelina Day of Giving. Dr. Vela Announces Javelina Relight Program During Presidential Inauguration

As part of his installation address, Dr. Robert H. Vela Jr. '94,'98,'03 announced the Javelina Relight Program for undergraduate students who have earned 90 college credits and who have paused or stopped their educational journey in the last five years.

"I am committing to awarding eligible students working toward graduation up to \$2,500 in scholarships," he said. "Our commitment to our students doesn't end because life may throw them curveballs, and they find themselves sitting out a semester or two or three. We are here to fulfill our promise to them—doing everything we can to help them graduate and set them on a path toward a brighter future."

Vela sees reigniting campus pride as one of his most important goals for the future of Texas A&M University-Kingsville.

"I want to bring back that sense of pride and tradition here at Javelina Nation and for us to understand that we are the university of choice for a lot of families, especially those that are first-generation college students," Vela said. "I want to ensure we are an opening, welcoming institution and that we are able to provide the resources the students need to not only enter through our front doors but also cross the finish line with their baccalaureate degrees and more so they can begin to transform themselves, their families and future generations to come. It's a game-changer, and we are up for the challenge."

"We want to insure our students come here and have the resources and engagement opportunities they have with the quality instruction made up of amazing faculty and staff. They will be fully prepared to tackle their careers," Vela added.

TEXAS A&M-KINGSVILLE RANKS 75th in Nation for Social Mobility by U.S. News and World Report

Yexas A&M University-Kingsville was named a Top Performer in Social Mobility, as determined by U.S. News and World Report. The publication ranked the university among the top 10 public universities in Texas to make the list's Top 100. The university ranked #75 in the nation.

The social mobility designation factors in the number of Pell grant-awarded students a school enrolls and how many of those students then graduate with their degree, looking at six-year graduation rates. U.S. News and World Report notes the majority of Pell grants are awarded to students whose families have an adjusted gross income under \$50,000.

"We know earning a degree can be life-changing for a student and their family and even more so for those who are awarded Pell grants in order to fund their education," Dr. Robert Vela Jr., President of Texas A&M-Kingsville, said. "To be acknowledged for providing a world-class, affordable and, ultimately, an attainable education to our students is an honor."

The publication assessed 1,500 institutions across the nation, and the ranking methodology looked at a school's academic data, enrollment figures and degree completion rates of students who entered institutions in Fall 2015, as reported to the Integrated Postsecondary Education Data System (IPEDS). Social mobility was assessed by evaluating two factors: a university's Pell recipient graduation rates and Pell graduation performance, which compared six-year graduation rates among students who received Pell assistance and those who didn't.

In Texas A&M-Kingsville's 2015 student cohort, Pell grant recipients made up 55% of students enrolled at the university. When it came to graduation rates, of the university's 2015 student cohort that graduated in 2021, Pell grant recipients made up nearly 51% of the graduates.



Students Receive Standout Support During 2022 Javelina Day of Giving

The third-annual Javelina Day of Giving for Texas A&M University-Kingsville was held Sept. 15, 2022, garnering a record-breaking total of more than \$575,000 in funds raised for our university. With over 850 participants in the campaign, the steadfast support of our university donors and their impact on the lives of Javelina students is undeniable.

The one-day annual fundraising effort highlights the collaborative relationship between Texas A&M-Kingsville faculty, staff, alumni and students, as well as the greater South Texas community. Students have become more involved with the event each passing year by encouraging donors and sharing how the Day of Giving personally impacts their lives – and they've seen tremendous success as a result.

Perhaps the best example of this is the Javelina Men's Basketball Team; raising \$70,000. Former head Javelina Men's Basketball Coach Johnny Estelle shared that these funds will be used toward scholarships, facilities, nutrition and team travel, allowing the team an opportunity to perform at a championship level.

As an alumnus of Texas A&M-Kingsville himself, Estelle understands firsthand the impact of donor support on student success, stating, "One of the most profound issues deterring graduation or academic success continues to be financial support, whether from home or within the university. I am convinced and have witnessed our contributions in the past provide solutions to some of these problems and allow more students to achieve greatness." He continued, "This, in turn, should and will initiate a 'cycle of success' in these students' future families, which will establish a 'standard of excellence' for generations." Earning the title of the top-performing program during the 2022 Javelina Day of Giving was the Frank H. Dotterweich College of Engineering with \$75,000 raised. Diving into the impact of the generosity of its donors, Professor and Dean of the College of Engineering Heidi A. Taboada, Ph.D., gratefully shared, "Funds raised from the 2022 Javelina Day of Giving allow us to continue offering the top-class engineering education that people have come to expect from TAMUK Engineering."

She concluded, "In general, we plan to use the funds under the umbrella of student success: student leadership experiences and professional opportunities or any other type of high impact practice. The idea is to use these funds on anything that will either remove hurdles from our students' lives or give them the tools needed to make them more competitive."

As a current animal science and pre-veterinary student as well as the leader of the TAMUK Rodeo Club – which saw great success on Sept. 15th – Jordan Stepan encourages others to give back to student organizations "because [donors'] contributions and support allows clubs and teams to accomplish their goals." She detailed the club's plans for the future, concluding, "The TAMUK Rodeo Club plans to use Day of Giving donations to continue enhancing the Rodeo Facility, host rodeo events, and fund clinics and community outreach events."

Javelina Golf to Enjoy State-of-the-Art Indoor Facility Thanks to Generous Alumnus

Our newest Javelina Society inductee, Fred Steves '70, has a dedicated history of support for Javelina students. In 2018, he and his wife, Peggy, invited and graciously hosted the Javelina Golf team for a round of golf at their home course in Floresville, Texas, followed by a lunch. What resulted was a wonderful relationship between the two that perseveres today.

When his wife passed away shortly after this visit, in April of 2018, Steves decided that a meaningful way to honor his wife's legacy was by remaining steadfast in his support of the Javelina Golf team. Searching for how to truly make a difference in the lives and success of the student-athletes, Steves noticed the challenges faced by the team with on-campus facilities.

It was announced in October that Steves will donate the funds necessary to renovate an existing racquetball court in the Steinke Physical Education Center (SPEC) into a state-of-theart, indoor training facility for the Javelina Golf team.

The space will boast digital hitting bays with modern launch monitors, swing analysis software, netting, tee pads, practice putting green, lockers and furniture. "My desire is for our Javelina Golf team to play for championships," Steves remarked. "If this facility can help the team reach that goal, I'm all in."

Acknowledging the tremendous impact this donation will have on the Javelina Golf program, Executive Director of Athletics at Texas A&M-Kingsville, Steve Roach, commented, "Fred has a champions mindset. He has developed a great relationship with Coach [Stefanie] Maynard and our women's golf student-athletes. Winners bet on winners and he's betting that our team will play for championships. This donation will help us in that goal."

Head Javelina Women's Golf Coach Stefanie Maynard reflected these sentiments of appreciation, stating, "The team loves Mr. Steves, and we are grateful for his support. This facility has created excitement for us and will be an important tool for me when recruiting players. We cannot wait to get in and have Mr. Steves down for the ribbon cutting."

Steves previously created an endowment at Texas A&M-Kingsville, bearing the name of both he and his beloved wife, intended to support students studying agriculture or education, Honors College students and Javelina women's athletes. His generosity is a wonderful model of enjoying the benefits of interaction with students by giving now, while also using his estate to impact the lives of future Javelinas.



TEXAS A&M UNIVERSITY-KINGSVILLE CELEBRATES NEW PARTNERSHIP WITH COASTAL BEND FOOD BANK

Texas A&M University-Kingsville celebrated a new partnership with the Coastal Bend Food Bank with a ribbon-cutting ceremony on Friday, Sept. 9, 2022, at the university's Javelina Care Closet, a food assistance pantry located on the university campus. With the food bank's support, the Javelina Care Closet will be able to provide additional food support and resources for students facing issues of food insecurity.

"One of the things we say at the Coastal Bend Food Bank is that we feed with impact, and we deliver hope," said Robert Morales Jr., Development Coordinator with the Coastal Bend Food Bank. "What this closet is going to do is, you're going to be feeding with impact, but more importantly, you will be delivering hope."

A survey conducted by the university in fall 2021 indicated that housing and food insecurity are significant concerns among enrolled students. According to the surveyed students, 42 percent reported eating less because they feared there was insufficient money for food.

"We know that many of our students, from a recent survey, deal with food insecurities to a much higher level than what we originally knew," said Kirsten Compary, Assistant Vice President of Student Affairs and Dean of Students at the university. "This is a great partnership and a great time for us to better meet the needs of our students."

The food pantry is a service that has been available on campus for students for nearly four years, Compary said in her remarks during the ceremony.

The university also revealed a new rebranding after incorporating a professional clothing closet that was previously located within the university's Career Engagement department. Students can utilize the closet to find clothing to help prepare for interviews, internships, or student teaching. "This is family helping family," said Dr. Robert Vela, President of Texas A&M-Kingsville. "We are a family, and there's no judgment. There's no lesser value placed on someone simply because they need help.

"This is going to get bigger, it's going to get more dynamic and we're going to have more partners," Vela said. "I can't thank the Coastal Bend Food Bank enough for saying, 'we believe in you.' They're our first partners, but get ready. We're going to get other partners to come in a collaborative fashion to help this amazing effort."

Historical Ranch Gift Becomes Largest in University's History

The historic H.R. Smith Ranch near Campbellton, Texas, has been gifted to the Texas A&M University-Kingsville Foundation for the benefit of and to be managed by the King Ranch[®] Institute for Ranch Management (KRIRM). Gifted through the estate of Mary Carroll Sheets Gregory, H.R. Smith's only child, the ranch and the accompanying monetary gift are the largest in the University's history valued at over \$30 million.

The ranch was established in the 1930's by legendary South Texas oilman, H.R. Smith, and named Hacienda de la Tordilla, or Land/Estate of the Dapple-Grey, for the surrounding hills that resembled the spotted horse at sunset. Spread out over approximately 8,000 acres, H.R. and his family never lived at the ranch full-time but enjoyed it as a retreat, even raising Palomino horses and hosting guests in the meticulously designed Spanish-style main house which is surrounded by oak trees and sprawling views.

The gift of the H.R. Smith Ranch allows KRIRM to vertically integrate many of its ongoing efforts and will provide a foundation for applied research to support teaching and offer ranch managers the tools and information to successfully create and maintain environmentally sound, socially responsible, and economically viable ranches.

"This is a unique opportunity for KRIRM students to have the ability to conduct applied research on a ranch managed by the Institute," said Clay Mathis, PhD, Director of KRIRM. "This is what we do and what we train them for. Adding this valuable component to their education will not only strengthen their skills, but also set them apart from other ranch management students."

Through best practices of strategically managing the ranch's natural resources and various agricultural enterprises, KRIRM will not only ensure the history of the family and the ranch are preserved but will also fulfill its mission to sustain our ranching heritage.

"Are you looking to pursue a future in music?"

This was the question that stopped Amanda DeFrees '21 – a then-high school junior – in her tracks while attending a Texas Music Educators Association (TMEA) conference. The Texas A&M University-Kingsville faculty member who sparked the conversation promptly handed her a flyer.

That flyer detailed Javelinas Upbeat Music Project (JUMP), a grant-funded summer music camp initiative, specifically for female students headed into their senior year of high school. It was DeFrees' decision to attend JUMP that changed the trajectory of her life, forever. Having built countless close-knit relationships – from the camp counselors to the percussion faculty – DeFrees knew that Texas A&M-Kingsville was the university for her.

Excited to begin her college career, DeFrees tirelessly applied for scholarships and was thrilled to be chosen as a recipient of the Olga R. Paul Endowed Scholarship. The endowment's namesake, Mrs. Olga R. Paul, passionately taught journalism for more than 30 years at Bishop High School. In honor of her legacy and to continue her decades of influence on the youth of South Texas, her son, Carl F. Paul '63, established the Olga R. Paul Endowed Scholarship Fund to support liberal arts students within the Texas A&M-Kingsville College of Arts and Sciences.

A talented drummer, DeFrees began her time at A&M-Kingsville as a Jazz Studies major. She performed in various ensembles and was a dedicated member of the Javelina Marching Band. DeFrees also steadily built a reputation as an amateur videographer after she routinely mounted a GoPro camera to her drum set, uploading marching band performance videos to her YouTube channel.

Not only did DeFrees unearth a natural talent for capturing and editing video, she discovered her true passion for media. "There were way more things I could do with media than I could do as a musician, so I decided to pursue that route," she explained. Luckily, a communications major is under the College of Arts and Sciences, allowing DeFrees to remain an Olga R. Paul Scholar.

DeFrees' first paid media job came while she was a student and was from an unlikely place – Intercollegiate Athletics. After meeting John Montoya, the Sports Information Director at the time, "he took me in as their sports photographer," she shared. After more than a year in this role, DeFrees craved more responsibility and creative opportunity, so she offered to film videos for Javelina Athletics.

Her time and talent in this role didn't go unnoticed, and her portfolio of work continued to build. So, although she was happily employed in San Antonio after her graduation from A&M-Kingsville, her goal was to return to media and marketing in the music industry – the work that began it all.

It was an advertisement on Facebook for an open position, Creative Media Designer with the Austin-based company Ultimate Drill Book, that caused DeFrees to think, "This is everything I'm looking for."

It was the challenging rounds of interviews, and her task as a finalist to travel to Austin, visit a local school, film and deliver a completed video within 48 hours, that excited DeFrees most. When she was selected for the position, she was nothing but eager to get to work.

DeFrees advanced quickly within the company, which she credits fully to leaving college with two-to-three years of professional

experience. After only five months at Ultimate Drill Book, she was promoted to Director of Media.

The relief DeFrees felt in not needing loans to cover her college expenses is something she admittedly was unable to fully appreciate until after graduation. But understanding her professional experience gained at A&M-Kingsville and the opportunities our university allowed her, she feels compelled to give back.

"I'm fortunate to be in a job I'm super passionate about," DeFrees shared. "I feel like it's my responsibility to help someone else achieve that as well."

DeFrees, a self-described "workaholic," thrived in an environment where opportunities existed for those who work hard to attain their goals. Because of generous and caring university supporters, De-Frees envisioned a future she had not originally considered for herself.

So, in November 2022, to pay it forward and to recognize how grateful she was for the support she received from the Javelina Family, DeFrees created her very own scholarship. The scholarship will be awarded in Fall 2024 for students majoring in

communications with an interest in music, or who have previous band, choir or orchestra experience.

In her current professional role, DeFrees is encouraged by her supervisors to pursue a passion project – something not necessarily related to the work that the company does, but one she should dedicate 10 percent of her time to. Driven by her steadfast ambition, she made a bold choice – a podcast.

She took on fully the production entirely by herself, setting up the entire studio: light, sound, video and still photography. The podcast, titled "Fem Forte," will feature female leaders within the music education community. One of her first guests is Dr. Elizabeth Janzen, co-director of A&M-Kingsville's School of Music. The same faculty member who, years ago, invited DeFrees to an immersive music camp called JUMP.

"Since I've known her, Amanda has been a strong, creative young woman who has not been afraid to forge her own path," Dr. Janzen exclaimed. "I am delighted that music at TAMUK played an important role in fostering that, and I'm excited to follow Amanda as she continues to create success in, and advocate for, the arts." The Texas A&M System Board of Regents approved the formation of the Mexican American Studies Institute (MASI) at Texas A&M University-Kingsville. MASI will be under the direction of Dr. Alberto Rodriguez, Associate Professor of History.

"The Mexican American Studies Institute was established to honor and showcase the legacy of Mexican Americans in the Coastal Bend, South Texas and the Borderlands areas," Rodriguez said. "At the center of the Mexican American Studies Institute are Texas A&M-Kingsville students, staff and faculty who will teach, research and analyze the experiences and histories of peoples of Mexican origin."

As an institute, students, staff, faculty and community members who are catalysts of cultural practices will be engaged to expand the historical and contemporary knowledge of Mexican American activism in the Texas-Mexican borderlands, he added.

"MASI is part of our university's designation as a Hispanic-Serving Institution that supports our students and provides them with academic spaces for learning about their history and culture. The institute shares this with the broader community to provide an enriching environment for all," Rodriguez said.

The institute will provide continuing education on the plights, struggles and achievements of Mexican American people and will reveal how our students can improve the future of their communities. "These conversations will recognize and honor indigenous and Mexican ancestries. Students will lead actions and conversations on the legacies of Mexican-origin people and their contribution to the Coastal Bend and South Texas."

"MASI also will provide a safe space for our Deferred Action for Childhood Arrivals (DACA) students that attend Texas A&M-Kingsville. The institute empowers our students and generates a vested interest in our university by showing them how to take what they have learned in the space and create positive change in their communities," Rodriguez said.

In addition to Rodriguez, MASI will be led by an advisory board that will meet once a year. Members of the advisory board are Michael A. "Mike" Hernandez III, CEO of D&M Leasing and the A&M System Board of Regents; Dr. Emilio Zamora, George W. Littlefield Professorship in American History at University of Texas at Austin; Homero Vera, Director of the Kenedy Ranch Museum of South Texas; Alvaro (Al) Hinojosa, retired Vice President of Holt Cat; Lizette Gonzales, Research and Graduate Studies Proposal Administrator; and Jill Woodall, Chief of Staff, Office of Academic Affairs, Texas A&M University System.
